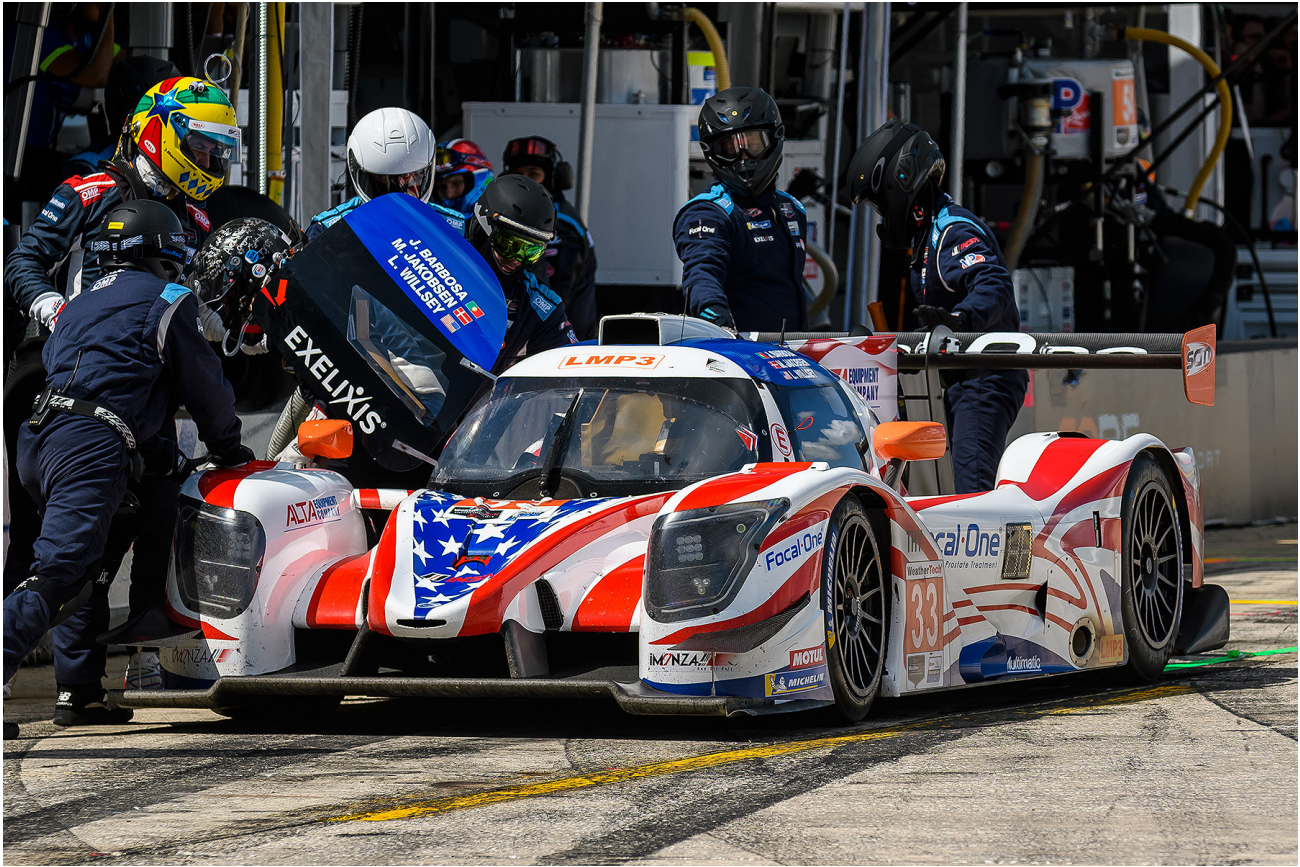

# Joao Barbosa Joins Knights



When Joao Barbosa competes in major international sports car races, he relies on the support of his pit crew. At each event, they prepare his car in the garage, take him through lightning-quick pit stops, and then repair any damage to the car following the waving of the checkered flag.

Barbosa currently drives in the International Motor Sports Association WeatherTech SportsCar Championship for Sean Creech Motorsports, co-driving the No. 33 Ligier JS 320 with Dr. Lance Willsey – winning his class in the famed 12 Hours of Sebring in March.

Away from the track, the 47-year-old native of Porto, Portugal has found a new support team – the Knights of Columbus. Barbosa, who now resides in Ormond Beach with his wife Mariana and sons Rodrigo and Gil – joined Father Eamonn Gill Council 13018 at St. Brendan Catholic Church in his hometown a year ago.

“I joined through a friend, Victor Silva,” Barbosa recalled. “My kids were going to school at St. Brendan Catholic School in Ormond Beach, and he persuaded me to become a Knight.

“If anything happens, you will have good support from the Knights of Columbus, helping you with whatever you need,” Barbosa added. “We had moved not that long ago [from Denver, N.C.], and we thought it would be important to have a support team around us in case something happened.”

After living several years in Ormond Beach, Barbosa relocated to North Carolina 10 years ago to live near Action Express Racing’s headquarters. When the team changed its racing program, he moved back to Ormond Beach.

“I’ve been traveling a lot for the last few years, and not spending a lot of time at home,” he said. “It’s always important to know that your family will be taken care of if something happens. We



had a great time at St. Brendan's when the kids were going to school there.

"Unfortunately, I don't get the chance to go to many of the meetings, but I follow what's going on through their regular emails," he said.

Silva's father also lived in Porto. He became friends with Barbosa several years ago, finally getting him to join the Knights.

"Joao is a good person and a great individual," Silva said. "But he's also very busy, traveling around the world. We've known each other for a number of years. Eventually, I expect to see him get more involved with the Knights, because he's very active with his wife and kids."

Very modest and quiet away from the race tracks, few of his brother Knights are aware of his accomplishments – although there was a rumor that a famous Formula One driver had joined the Knights.

While Barbosa has yet to drive in Formula One, he's very accomplished in international sports car racing.

He is a three-time overall winner of the Rolex 24 At Daytona, taking America's premier endurance event for Action Express in 2010, 2014 and 2018, in addition to winning the GTS class in 2003. He won season championships for Action Express in 2014 and 2015, co-driving with Christian Fittipaldi.

Barbosa was the 2004 Rookie of the Year at the 24 Hours of Le Mans, and finished fourth overall in that event in 2007 and third in class in 2011. He also won the 12 Hours of Sebring with Fittipaldi and Sebastien Bourdais in 2015.

He was the 2003 winner of the 1000-kilometer race at Spa Francorchamps, and won the Formula Atlantic Rising Star Award in 1997. A three-time Portuguese karting champion – finishing third in

the 1991 Formula A World Karting Championship – and was the 1994 Portuguese Formula Ford champion.

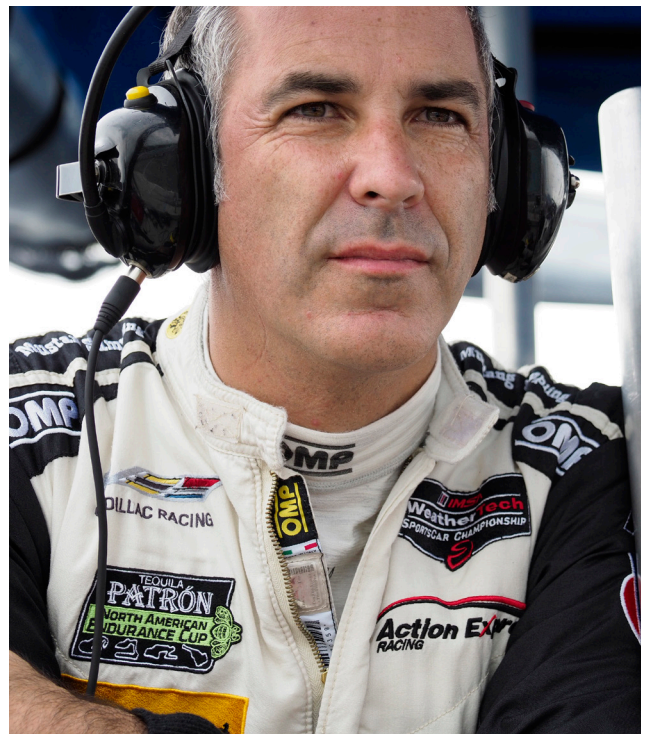
For 2022, Barbosa shows no signs of slowing down. He opened the year by finishing second in the Daytona 24 Hours and then won the LMP3 class

at Sebring to take the points lead in the Michelin Endurance Cup standings.

But when he finally decides to hang up his helmet, expect to see more of Joao – although probably behind the scenes – with his Brother Knights.

"The Knights do a lot of charity work, which is great for the community,

and I follow what the Knights do for St. Brendan school, they keep everything moving along and making life easier for everybody. I think that's great, and it's very important to have support from the Knights.



# A New Fraternal Year

**M**y Brothers in Christ, today, we begin the 2022-2023 Fraternal Year. Let us ask for God's blessing and begin with the prayer for Canonization of Blessed Michael J. McGivney, for the favor, pray that he will intercede on our behalf and that God will deliver to us an abundance of new and capable men, men who will help us build up His Church.

It is very important that we all understand the mission of our jurisdiction. With recent decisions by the Supreme Court of the United States, transferring powers back to individual states, we Knights must be highly visible supporters of right to life issues. We must step up our participation at events like March For Life, laps for Life, and at Ultrasound Initiative Dedications. We will continue to support Special Olympics events and our youth programs.

To do all the things that support the many programs we offer, we need help! Our intake goal for this Fraternal Year is 2,711 new members. This year we will need to increase our charitable contributions by 3% over the prior year and our programs will need to be increased 5%. With most parishes back to normal operations and few restrictions on meetings, due to the Pandemic, we should have no problem achieving the new goals. But we cannot wait until the end of the summer to begin! We must start today!

The Membership Team will be scheduling training sessions on "the how to's" of membership recruitment, starting in July. These should be attended by all State Officers, Directors, Programs and Charities teams.

The Supreme Council is encouraging all local councils to promote "Holy Hours" this fraternal

year, which will help with qualifying for the Star Council Award. Establishing a monthly Holy Hour, should be the goal of every council. Get with your local pastor and council chaplain to schedule the time and date for these important events.

Florida has been blessed with great State Chaplains over the years,

this year is no different with Father Robert Kantor as our State Chaplain. Fr. "Bob" has been truly a wonderful spiritual advisor for so many of us and we look forward to his guidance and support again this year. Fr. Bob as well as the diocesan chaplains are here as a resource. If you would like to hold a Corporate Communion or Rosary service, they can help you with the planning. The Supreme website also has many tools and materials for you to use. More than ever, we need to bring families together spiritually and to encourage them to pray together. Strength in prayer unites us as one.

# An Eastern Look At Holiness

**W**e, as human beings are called to holiness because we are made in the image of God. The Psalmist asked a burning question when he wrote, "What is man that You should be mindful of him, or the son of man that You should care for him?" (Ps 8:5).

Why is humanity so important in the plan of God? The immediate answer to the Psalmist's question can also be found in the Scriptures: specifically in the Book of Genesis where we hear God say, "Let us make man in our image, after our likeness" (Gen 1:26). What the Psalmist and the writer of Genesis is trying to tell us is that the "uniqueness of the human race is that it has been made by God to reflect His divinity in creation. That reflection is that holiness in each one of us.

If you and I as human beings are created in the image and likeness of God, then the more we understand about God, the more we understand about our human nature which gives us our moral vision. You and I now have a hint as to what makes us holy. It is our moral compass. The Church Fathers stressed that the "image of God" in us refers to those of our natural abilities which resemble His. We see therefore in Genesis God expressing Himself creatively by bringing things into existence. We have similar abilities to be creative and exercise choice. In this we reflect the divine image. In Genesis, we also see that God has the ability to discern, to judge, to appreciate. We, too, can express appreciation, gratitude, discernment, or wonder. In all of this, there is something of God. Another "image of God" within us that we share with God a sense of morality. Because of this, again, the Fathers of the Church say we have the divine image within us. Of all the attributes of God reflected in the Scriptures, one stands out as the most important. St. Paul points out this attribute very clearly. The Indefinable One is defined as "love". St. Paul says

love defines Jesus and as the body of Christ, we must express that "love" in our lives otherwise we are simply clanging symbols. Because of are capable of loving, we are set apart as the one component in God's creation who can image the God of love. How wonderful is that!

The heart of the "likeness of God" within us is holiness as described

and defined in Eastern Tradition. The heart of what is means to be God is holiness: that set apartness which marks God out from all of His creation. Although we cannot attain this holiness on our own, God gave us His Only Begotten Son as a model and inspiration for all of us. Jesus is the perfect man, completely fulfilling God's plan for humanity. This understanding is reflected in the Divine Liturgy of St. Basil the Great where in the anaphora St. Basil says of Jesus, "He is the image of your goodness, the Seal bearing Your perfect likeness, revealing You His Father through Himself". The purpose of Christ's coming among us, then, was to complete the Father's plan for humanity, to restore the likeness lost in the beginning. In the famous words of St. Irenaeus, "God became man, so that man might become divine". The Fathers of the Church called this process of recapturing the likeness of God through Christ by the term deification, to become Godlike. We can only become holy through those Godlike attributes of "morality" and as St. Paul says, "love".

What does it take, then, in order to become holy? It is to unite ourselves to Christ. In the Eastern baptism ceremony, the priest asks the parents and Godparents, for the child, three times: "Do you unite yourself to Christ". This is truly significant

because when the parents and Godparents answer "yes" for the child, the process of working toward holiness has now begun. We have been baptized long ago. In that baptism our work for holiness began. We have given our yes. It is extremely important that we make "holiness" the primary ministry in our lives. As it was taught to us as we were growing up, we must live that "holiness"

in our lives, so that others may continue to have an example of that unity between ourselves and that Triune God we believe in. Only in this way will we be able to be ministers of the Gospel and speak for and in the Name of Jesus Christ. We must become modern day "prophets", speaking for God to the world.

# Importance of ‘Followership’

**A**s we begin the new fraternal year, there’s no doubt that we have elected a great leadership team. And although there are many years of Knight’s related experience with these leaders, they still need our help and support as followers to make this year even better than the last.

When we talk about leaders and leadership, we also need to include followers and ‘followership.’ ‘Followership’ is important for many reasons, primarily without followers there are no leaders. For any organization to succeed, there must be people who are willing to follow effectively, just as there must be those who are willing to lead effectively.

While ‘followership’ may not sound as glamorous as leadership, there is absolutely nothing wrong with being a follower. In fact, having the qualities of a good follower are equally important to the success of any organization, as do the qualities of a good leader.

Followers are diligent, motivated, pay attention to detail and are committed. With the Knights of Columbus, that commitment includes the principles of our Order; charity, unity and fraternity.

Effective followers don’t just get things done, they keep leaders on their toes, help bring out their very best, and hold them accountable. Effective followers are also critical thinkers, but with a positive attitude. When they identify problems, they also identify and recommend solutions. When followers form a positive relationship with their leader, they are in a better position to potentially influence situations where they perceive the leader to be making a mistake.

When good leadership meets good ‘followership,’ good things happen. Within our own organization, one good example is the strong history we have of supporting pro-life pregnancy centers across the nation. Leadership started when the Supreme Council implemented the Ultrasound Initiative Program. ‘Followership’ is the successful raising of funds by local councils

to purchase ultrasound machines and placing them in faith-based pregnancy centers. The Florida jurisdiction has helped purchase more than 100 ultrasound machines. Council 10514, in particular, has assisted in the purchase of five ultrasound machines since 2017.

From 2018 to 2021, we have more than 1.7 million volunteer hours. Over this same period of time, the Knights donated more than \$18 million in funds and supplies to pro-life pregnancy centers and maternity homes.

In a recent press release, our Supreme Knight Patrick Kelly said, “As Knights, we are called to courage and self-sacrifice. Standing for life means making personal sacrifices for women and children in need — being willing to give of our time, skills and financial resources, and accepting the fact that the fruits of our labors are often hidden.”

In this same vein, on June 26, Pope Francis said in his Angelus address, “... Jesus helps us to be people who are serene, who are happy with the good accomplished, and who do not seek human approval.”

We need to know that what we accomplish at the council level has positive, far-reaching effects and it all starts here. Our support of LIFE is just one example of the impact our Faith in Action Programs have on our church and community.

We need to be aware, that even with the recent Supreme Court decision, old challenges will continue and we WILL be faced with new obstacles.

This is why, most importantly we need to know that our council, our church parish and our community need us more than ever.

All this to say, we need you to step-up and volunteer. I’m sure the officers and directors can use all the help they can get.

# Expanding Community Service



**I**n the August, 2021 Invocation, Our Lady of Mount Camel Council 13300 in Wildwood, published an article titled “Expanding Community Service.”

This article focused on an opportunity presented to our Council by Habitat for Humanity for Lake-Sumter Counties, in which we agreed to provide 200 hours of voluntary service for our fiscal year, July 2021 to June 2022. This being a new venture for our Council, we had no idea what may be involved nor if we could accomplish this goal. However, it fit within our Council’s goal of providing local support to those in need.

Our first projects in July 2021 got off to a roaring start in the categories of New Home Construction and Preservation and Repair Projects, providing 88 volunteer hours by the end of the month. Looking at the Preservation and Repair Projects, this category focuses on needy individuals and families who already own an affordable home but may require a little extra help in maintaining and preserving the safety of their home. Through this program, homeowners are able to stay in their homes in which they already live, while increasing the safety, accessibility, and beauty of the home.

For the balance of the year, Community Co-Directors Jim LoBue and Tom Kilbride worked with Carlos Beron, Director of Volunteer Services, Habitat for Humanity Lake-Sumter, Florida in directing our Council’s volunteer efforts onto “Preservation and Repair” projects. This type of

work ranges from pressure washing, yard cleanup, painting, building wood decks, wheel chair ramps, hand railings and helping with weatherization of the home. Each project has a site supervisor who directs the work and insures the safety of all volunteers. The overall goal of this work was to insure the homeowners have a safe home at the same time improving the community in which they live. The homeowners we have helped are proud of the improvements made to their property.

In a recent discussion of our accomplishments with Carlos, he recognized Council 13300 as the “go-to” resource for his Preservation and Repair projects. His reasoning was that these projects randomly come to the surface and require a quick turnaround – and the Knights have proven they can deliver. He summarized it by saying “your council is the go to group of volunteers who are flexible with meeting our ever changing needs.”

Council 13300 is proud to have established a great relationship with Habitat for Humanity for Lake-Sumter Counties, and we are also extremely pleased that we were able to assist so many homeowner’s improve their properties and communities they live in. We not only met the goal agreed to, but ended up with a total of 412 volunteer hours. And we have already begun our continuing support for Preservation and Repair Projects for our next fiscal year, July 2022 to June 2023.



# A Saint In The Making

**O**n May 26, 2020, Pope Francis approved a decree recognizing a miracle attributed to the intercession of Father McGivney and opening the way for his beatification. On Oct. 31, the Mass for Beatification was celebrated in the Cathedral of Saint Joseph in Hartford, Conn.

An Apostolic Letter was read from Pope Francis that declared Father McGivney would now have the title of Blessed Michael McGivney. He is the third priest born in the United States to be raised to this honor, and the first priest to be beatified who spent his whole priestly ministry in a US parish.

The pope's Apostolic Letter stated that Blessed Michael McGivney's "zeal for the proclamation of the Gospel and generous concern for the needs of his brothers and sisters made him an outstanding witness of Christian solidarity and fraternal assistance."

The Cause for Canonization for Father McGivney was opened in the Archdiocese of Hartford in 1997, when he was given the title Servant of God. On March 15, 2008, his heroic virtue was recognized by Pope Benedict XVI, and Father McGivney was given the title Venerable Servant of God. This important step occurred after years of careful investigation of Father McGivney's life, spirituality and holiness by the Congregation for the Causes of Saints. The

declaration of Venerable confirmed what those who knew him in life, and others who call upon him since his death, have believed about Father McGivney: He lived a life of heroic virtue with an extraordinary love of God and neighbor.

Having been raised to the honors of the altar, Blessed Michael McGivney has an annual feast day of Aug. 13, the day between his birthday

(in 1852) and the day he passed into eternal life (in 1890). His cause has now entered the final phase toward canonization or sainthood. One more confirmed miracle attributed to the intercession of Blessed Michael McGivney is needed for him to be declared saint.

All Knights and their families, as well as all those devoted to Father McGivney, are asked to pray for his intercession in their daily needs, especially in cases of serious illness, and to report any favors and healings to the Guild

# New Bishop of Diocese of St. Augustine

**T**wo short months ago on May 24, Pope Francis announced the appointment of Father Erik Pohlmeier as the next bishop of the Diocese of St. Augustine. For the past 24 years, Bishop-elect Pohlmeier has served as a pastor in the Diocese of Little Rock, which encompasses the entire state of Arkansas.

Bishop-elect Pohlmeier will become the diocese's 11th bishop.

Raised in Paris, Ark., Father Pohlmeier was ordained a priest for the Diocese of Little Rock on July 25, 1998. His last assignment was pastor of the largest parish in Little Rock, Christ the King, and director of the Faith Formation and Deacon Formation offices. He has been the theological consultant for the Arkansas Catholic newspaper for 19 years and director of continuing education of clergy since 2019.

Father Pohlmeier succeeds Bishop Felipe J. Estévez, who has served the St. Augustine Diocese for the past 11 years and is retiring at the age of 76. Bishop Estévez submitted his letter of resignation in February 2021, his 75th birthday, the mandatory age for bishops to retire. He has served the diocese for 11 wonderful years and the good news is he will continue living and ministering in the diocese as needed.

One of seven Catholic dioceses in Florida, the Mother Diocese of Florida has a registered Catholic population of more than 153,000 in 17 counties in northeast and north central Florida. This compares to the approximately 154,000 Catholics in Arkansas' 75 counties.

Reflecting on his appointment to the Diocese of St. Augustine, Father Pohlmeier said, "I am grateful for every way I have been called to serve the Church and am humbled by this opportunity to serve in the place where Mass was first celebrated in the United States. May God be praised for any good work I am able to do."

After his ordination, Bishop Pohlmeier will begin immediately meeting his flock across the



diocese. He will be celebrating Masses in the five deaneries of the diocese. The following is a schedule of Masses open to the community of the diocese:

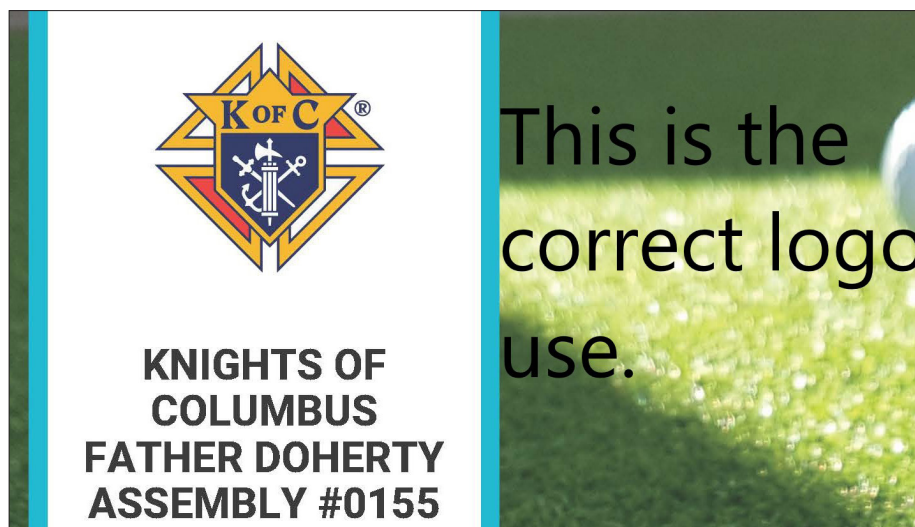
# Use of KofC Logo

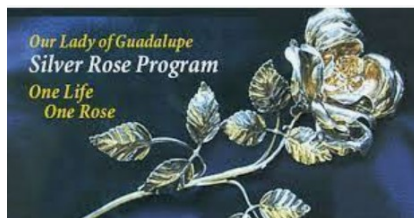

- Pictures need to be sent separately as an attachment and the original pictures **Please do not format them in any way, we will do it**-- not embedded in a Word document
- **Articles need to be brief, highly relevant and actionable**
- **At a minimum, Who, What, When and Where needs to be in the first paragraph,**
- Articles need to be brief, to-the-point and **of interest** to the entire State Council
  - What is the event/activity about?
  - Whom did it benefit?
  - What was the result?
  - Who are the key players/Knights?
- **Similar story** submissions will be consolidated/batched into one article by the Editors
- Authors must submit on time per the Editor production calendar- **Deadline 1<sup>st</sup> of each month**
  - Late submittals will be placed farther down the newsletter or not published.
- Proof your article carefully for spelling and grammar before sending (**use spellcheck**)
